Yes, the Incident Commander, Liaison Officer, Scribe, Public Information Officer, Safety Officer, Operations Officer, MDRT Team, Care Team, Safety Team, and possibly Student Accountability Coordinator.

2. Do you need to contact outside agencies to respond? If so, what agencies?

Yes, local police department (911) for the accident, EMS for the injured students,

AEP for the downed lines. Advise District personnel of the incident.

The local police and fire department arrive on scene. They close off a portion of the street and begin re-directing traffic down the nearest neighborhood road. The driveway for bus entrance is open, but the exit is blocked. The students that walk to school begin arriving. Power has not been restored, but is expected in a less than two hours.

1. What drill, if any, should you conduct?

Modified Lock Down: (Normal controlled access, because there will be a lot of outside agencies personnel on the in the area as well as onlookers)

2. Describe some of the responsibilities the following will have:

Liaison Officer – Contact Local Police, AEP, Division of Electricity, Superintendents Office, District Transportation Dept, identifies when responding agencies arrive at school and their location, log all their arrival and departure times, brief IC, etc.

Safety Team —Direct students to alternate entrance to school building, assist buses with drop off of students, set outer perimeter, lock exterior doors, assist with crowd control around accident area, etc.

Scribe – document time of incident, students and staff involved, first responders' activity, response, outcome, etc.

- 2. Will this incident require an "After Action Review"? If not, why? Yes, because any incident requiring IC action should be recorded and reviewed.
